Nursing Research plays a pivotal role in strengthening the science and practice of Nursing. As we engage in research, it is important that we are equipped with the necessary competencies to ensure that this is done in an ethical way to protect our clients, partners and nurse researchers. This is ensured by undergoing ethics review. Moreover, Ethics Review Boards are being set up in key institutions but are usually made-up on non-Nursing members. It is high time to be represented and advocate for ethical conduct of quality nursing researches.

In line with this, the Philippine Nurses Association, Inc. cordially invites you to the 2-day workshop on Good Clinical Practice and Basic Research Ethics, with title *Good Research Practices Workshop* to be held on <u>May 02-03, 2019</u> at the AGT Auditorium, PNA National Headquarters in Benitez Street, Manila.

This workshop is organized in partnership with the Philippine Health Research Ethics Board (PHREB) of the Philippine Council for Health Research and Development-DOST, the national policy making body in health research ethics. As the prime mover in ethical research, PHREB has set the requirements for accreditation of all Research Ethics Review Committees (RERCs) in the country to ensure adherence to the universal principles for the protection of human participants in research.

Through this workshop, PHREB will issue a certification for Good Research Practices to participants who complete the 2-day course requirements. This certification is a requirement for conduct of research in institutions and publication in reputable journals.

Registration fee is Php 4,000.00 regardless of being a PNA member or not, and is open for all allied health professionals.

Participants are required to submit a Participant Registration Form on or before April 30, 2019 to reserve their slots. These details are required by PHREB. <u>Slots are limited to only 50 individuals</u> to ensure adequate facilitators for the workshop and small group activities.
