- o Holder of updated PRC I.D. to practice nursing in the Philippines;
- Masters degree holder in Nursing and any health related profession
- Three (3) consecutive years of active membership in the regions/ chapters which he/she represents;
- o Endorsed by the Board of Directors signed by the majority of the chapters / regions duly notarized

# <u>Duly Signed Clearance from their respective chapters and from the PNA</u> National Office.

- o Proven leadership ability;
- Available, accessible and committed;
- An active officer of PNA;
- Works for the interests of the association.

Must have served as a member of the Board of Directors in your Chapter for at least one (1) year prior to election.

#### **COMELEC Commissioners:**

- Active member of PNA;
- Updated PRC ID to practice nursing in the Philippines;
- Had served in any capacity as a PNA officer either in the National or Chapter Level;
- o Recognized nursing leader with integrity, objectivity and impartiality;
- o Masters degree holder in Nursing and any health related profession
- Endorsed by the Board of Directors signed by majority in any Chapter within the Region duly notarized
- <u>Duly Signed Clearance from their respective chapters and from the PNA</u>

- Should not be an incumbent officer in any capacity in the association.

- 5. Pledge of Commitment embodied in the Certificate of Candidacy.
- 6. Statement of Plans and Program of governing the PNA.
- 7. Accomplished Waiver and or Disclosure of Conflict of Interest.
- 8. Clearance form duly signed.
